1 Meeting conduct

1.1 Apologies

All members were present.

1.2 Public forum

Donna Brooke on behalf of the:

- 1. Tairua Information Centre provided an update on the launch of the Information Centre's website on 6 July. It was also noted that a number of Pauanui businesses were advertising on their website. The Information Centre Annual General Meeting will be held on 31 August 2017.
- 2. Tairua Business Network was seeking sponsorship for the refurbishment of the hanging baskets in the town centre this summer. The Area Manager undertook to follow this up with Smart Environmental.
- 3. Tairua Hall Committee asked if a veranda could be built on the front entrance of the Hall to weather proof it for wheel chair access specifically when unloading from the community van. It was suggested that they approach the Tairua Troubadours for funding for this as they had funds available for community projects. The Hall Committee would also like to see the grounds outside the Hall beautified with gardens, steps down to the grassed area below the Hall and a picnic table installed as this area was becoming popular for family groups picnicking. This would be referred to the Parks Field Representative.

Joyce Birdsall on behalf of the Guardians of Paku Bay asked if the green painted marker posts in Grahams stream to identify the water and wastewater pipelines could be removed now that the work was completed. The Area Manager undertook to follow this up.

Tony Jacobs on behalf of the Tairua Residents & Ratepayers Association Incorporated:

- Provided a general update which included their support for the Pepe walkway, Council's draft Mangrove Management Bill and the meeting they organised with NZTA and concerned residents regarding the SH25 reseal road noise.
- Expressed their disappointment that the Property Maintenance & Nuisances Bylaw was not adopted.
- WRC had approached the Association with regard to establishing a memorial to the late Derek Boyd to recognise his efforts with the Grahams Stream works. They would be happy to provide a couple of trees and it was also suggested a memorial seat be established in the reserve overlooking Grahams Stream. This would be followed up with Council staff.

2.1 Council Leasing Policy review

The Community Board was presented the revised Leases and Licences to Occupy Policy for endorsement. Also presented for the Community Boards' consideration was the total quantum of rates which were not currently on-charged to lessees and were met by each Community Board.

Key Discussion Points

- The Board would like to see a list of the community and emergency services organisations that make up the \$19,000 in rates paid in the Tairua-Pauanui ward.
- It was important that organisations know the cost of rates as someone has to pay these and if it is not the lessee or licence holder then it is the ratepayer.
- The Board has the discretion to review the paying of rates at the time there is a rent review.

Councillor Walker noted that the draft Mangrove Management Bill has gone to Parliament for lodgement.

Board member Campbell provided an update on the 'Paradise Coast' rebranding and noted that the Whangamata Business community supported it and Tairua were now running with it. She will be attending the Coromandel Arts Advisory Board meeting on 5th July.

Councillor Bartley expressed his disappointment with regard to how the Pauanui Trail public meeting held at the Hikuai Hall was organised and noted that the organiser was informed that the right people could not be at the meeting,

Board member Turner would like to see a formed track to Patrick Heath Memorial Reserve. The parking issues at Tirinui Crescent had been discussed with Roading staff and residents. Roading have a proposed solution which includes signage and road marking for these issues. He felt that a one-way road system could help alleviate possible trailer boat parking congestion at the Tairua wharf. Board member Turner tabled documents he had received from Hikuai residents to the Tairua Pauanui Trail.

Board member Brooks attended the Tairua Information Centre and Business Network meetings. He noted that the Hall Committee would like to see the outside of the Hall tidied up with gardens and steps down to the grassed area below the Hall with a picnic table.

Board member Renton has attended a number of Long Term Plan workshops.
