### 1 Meeting conduct

### 1.1 Apologies

All members were present.

#### 1.2 Public forum

Joyce Birdsall on behalf of Walk Tairua Society Inc thanked the Community Board for the community grant received to assist with the signage on the Pepe walkway.

Tony Jacobs on behalf of the Tairua Residents & Ratepayers Association Inc provided an update from the association:

- Organised a 'meet the candidates' meeting in Tairua on 16 September.
- Supported the Tairua Butchery in the Hauraki-Coromandel Business Awards.
- Provided liaison with NZTA regarding the reseal of SH 25 between the one lane bridge and the school with small chip which they undertook to complete in October.
- Contacted WRC regarding sediment control in a few isolated areas of the forestry block north of Tairua to help reduce run off into Graham's Stream.
- Supported request for the boat haul out area being reinstated in the Tairua harbour.
- Worked with Dean Allen to address harbour concerns.
- Invited the community to contribute towards the installation of a memorial seat in recognition of the late Derek Boyd's work in protecting our environment, more particularly Graham's Stream and also thanked the Community Board for their contribution.
- The Whenuakite Kiwicare Group were invited to their meeting last week and spoke about the ongoing challenges in maintaining predator control in the area.

Donna Brooke on behalf of the Tairua Information and Community Services Society Inc spoke to Item 2.1 on the order paper noting that the timeframe had got too late for the Information Centre to relocate before Christmas, and that this would now be proposed for April 2018.

Sam Taylor, Tairua Information Centre Manager thanked the Community Board for the community grant towards the summer series again this year.

### 2 Governance

### 2.1 Tairua Information Centre - proposed relocation

The Community Board considered a request from the Tairua Information & Community Services Society Inc. to temporarily relocate the information centre operation to the meeting room in the Tairua Library building, 2 Manaia Road, Tairua.

#### 47/17 Resolved

TPCB That the Tairua-Pauanui Community Board:

- 1. Receives the 'Tairua Information Centre Relocation' report dated 8 September 2017.
- 2. Supports the request from the Tairua Information and Community Services Society Inc. to relocate the operation of the Tairua Information Centre to the Tairua Library meeting room, on a temporary basis only, subject to further discussions with affected staff and approval by the Community Facilities Manager.
- 3. Instructs the Community Facilities Manager to enter into discussions with affected staff prior to making any recommendation to Council to enter into a lease with the Tairua Information & Community Services Society Inc to temporarily relocate the operation of the Tairua Information Centre to the meeting room in the Tairua Library building at 2 Manaia Road, Tairua prior to April 2018.
- 4. Instructs staff to prepare a report for the next community board meeting on how this relocation will progress.

### 3 Local Activities: Policy/Levels of Service Operational

## 3.1 Tairua-Pauanui Long Term Plan budgets for footpath construction and kerb and channel installation

The Community Board was asked to confirm whether they wanted to allow budget for new footpath construction in Tairua-Pauanui and kerb and channel installation on Ocean Beach Road in the 2018-28 Long Term Plan.



#### **Key discussion points**

- It was noted that it was proposed to yellow line Tirinui Crescent. While this would alleviate the problem for property owners it would create problems for the public.
- There were no footpaths for the public to walk up from Paku Drive to the start of the Paku summit track and the reserve walkways were too steep and slippery.
- Staff would arrange a meeting with the Roading Engineer and Community Board members on site at Tirinui Crescent to look at various options with a report being presented to the Board at their November meeting.

# 6.1 2017/2018 Tairua Pauanui Community Board work programme - update

The Community Board received an update on the 2017/2018 work programme.

#### **Key discussion points**

- Kennedy Park car park project. The Board Chair met on site with the Project Manager who had since provided options available and the work was programmed for October 2017.
- Waterways tennis court resurfacing. Two quotes had been obtained and are currently being evaluated by Project Management Office staff.

### 6.2 Members' reports

Board member Campbell attended a Paradise Coast meeting in Whangamata with the working group. Whangamata were now organising their own meeting with the business community. The working group was looking at fund raising options with an Arts Trail event. The vacant position in Tairua on the CACIA was currently being advertised.

Councillor Walker noted that the CACIA have set up a trust under the Arts Coromandel banner. The CACIA Board have discussed the Pauanui event and while it had their support it was too early in their development to provide input. He met with WRC regarding the Mangrove Management Bill.

Board member Brooks attended a Hall Committee meeting. They were progressing the design for the steps down to the beach from the Hall. He would like Council to look at installing soap dispensers in the Pepe toilet block in the interests of hygiene. Staff would organise this with the installation cost limited to \$200. No update received this month from the Heritage Group on where they were at with the replacement of the history trail plaques.

Board member Turner attended the Tairua Residents and Ratepayers Association Inc meeting. They had requested a copy of the Long Term Plan. Staff noted it would be available in March 2018. He also noted the following:

- Skate group was looking at proposed sites.
- Requested a workshop be held in Tairua on how to use the Paradise Coast tool box.
   This request would be passed on to the owners of the Paradise Coast brand.
- Tairua wharf grid. WRC had advised that this was not their responsibility and they did
  not want to own it. However, in an emergency a temporary structure could be put in
  to tie a boat up to.

Councillor Bartley noted the proposed relocation for the Tairua Information Centre.

Board member Renton met on site with the project manager for the Kennedy Park car park project. He also noted there was to be a meeting this week with Infrastructure staff and the people from the beach front community to resolve issues. He had attended a number of workshops at Council.
