SUBJECT	Proposed reserve renaming - 89 Manaia Road, Tairua

1 Purpose of report

The purpose of the report is for the Tairua-Pauanui Community Board to consider recommending to Council the renaming of the local purpose reserve (esplanade) known currently as the 'Hornsea Road estuary reserves' as the 'Derek Boyd Reserve'.

2 Background

The Tairua-Pauanui Community Board at its 20 November 2017 meeting received a request (**Attachment B**) from the Tairua Residents and Ratepayers Association (TRRA) to name the Local Purpose Reserve (Esplanade) between the Tairua Bowling Club and the Manaia Bridge as the 'Derek Boyd Reserve' in recognition of the contribution Mr Boyd has made to the Tairua area. Mr Boyd's family are supportive of the Tairua Residents and Ratepayers Association's proposal.

The reserve comprises Lot 119 DPS 27, Sec 7 Block X Whitianga SD and Part Lots 108 DPS 27 (**Attachment A**).

3 Issue

This land is currently identified as the 'Hornsea Road Estuary Reserves' in the Tairua-Pauanui Reserve Management Plan and forms part of a link on the northern side of Manaia Road, from the Manaia Road Bridge to the Cory Park Recreation Reserve (Bowling Club). Renaming a reserve requires a Council resolution.

4 Discussion

The Board would need to begin the official process for naming this reserve as the 'Derek Boyd Reserve' in order to satisfy the request from the Tairua Residents and Ratepayers Association.

In accordance with Part 3 Section (10) of the Reserves Act 1977 the Council (as the administering body) may by notice in the Gazette, declare that a reserve shall be known by such a name as specified in the notice.

The Community Board may wish to consult with local iwi and hapu before undertaking actions and making decisions about any reserves it administers.

5 Suggested resolution(s)

That the Tairua-Pauanui Community Board:

1. Receives the report 'Proposed reserve renaming - 89 Manaia Road, Tairua' dated 23 January 2018.
2. Recommends to Council to name the local purpose reserve (esplanade) identified in the Tairua-Pauanui Reserve Management Plan as the 'Hornsea Road Estuary Reserves' as the 'Derek Boyd Reserve'.
3. Delegates authority to the Chief Executive to declare by a notice in the Gazette that the Local Purpose Reserve (Esplanade) shall be known as the 'Derek Boyd Reserve'.
