Even though this project was driven through community empowerment, there have been some unforeseen costs and also significant post production costs, that was recently unsuccessful in applying for an Arts Grant through Thames Coromandel District Council.

The song and video are a successful project, and is and will be for the foreseeable future, an asset and tool in marketing Paradise Coast to a wider audience bringing awareness and encouraging people to visit and live here permanently.

The breakdown is as follows

Beside the Seaside \$2380.50 details as per invoice attached.

Anaru Pilcher for \$900 as per attached invoice. This was an unforeseen cost. This young 17-year-old boy dedicated his time and his gear to make the video. Unfortunately, during filming the drone hit a powerline causing significant damage and we would like to help him with the repair costs. Invoice attached.

Tina Cross for \$575.00. This is an appearance fee for singing the song on Saturday 20th Jan at the inaugural release of the song. Anaru videoed this appearance and we have this to use as part of our media campaign for when the website is released.

We are using the 2017 grant money from the community board which we have in the bank for the website, as we need technical help to add the toolbox to the site plus events pages as we did for the Richardsons Parachute Drop and we hope to do the same for Beach Hop. We have already got the website being hosted and info@paradisecoast.co.nz set up.

The balance of the money is going into registering the incorporated society and trademarking.
