Chairperson Pritchard noted that the 200th anniversary of the arrival of the HMS Coromandel and therefore the 200 year anniversary of the naming of Coromandel was pending in June 2020. The Board was advised that a brainstorming session had been called to discuss this event and begin the initial planning.

Councillor Brljevich noted that the LTP Consultation Document would be going out for public consultation on 16 March and also that the Community Service Awards were now open.

Member Autumn advised that she had attended the Community Arts Council meeting. She raised concerns regarding the policing of the freedom camping bylaw, particularly in the carpark across the road from the Council building. Ms Harrison advised that the bylaw officers were out checking from 6am to ensure campers were complying.

Member Autumn advised that the Amodeo Bay bridge was collapsing slightly with cracks underneath and she would lodge an RFS. There was discussion regarding the Kereta toilet and staff advised that this project would be put forward for consideration in the funding application to the Tourism Infrastructure Fund.

Member Stephenson advised he was waiting to hear on the legal department at Council for a potential variation of the lease at Tucks Bay.
