### 1 Purpose of report

To present the submissions received to the Council's Long Term Plan consultation for the hearing of submitters. The purpose of this hearing is to give submitters an opportunity to present their submission verbally to elected members. Council will make its decisions on the Long Term Plan and associated policies at deliberations meetings scheduled for 15 -17 May 2018.

### 2 Background

Council adopted the Long Term Plan consultation document, the supporting information and the associated draft policies for consultation on 13 March 2018. The consultation period was from 16 March through to 16 April 2018. During this time the consultation was advertised through local radio, print media, online and billboards. Public meetings and market day stalls were held across the Peninsula.

782 submissions were received on the consultation, including 8 late submissions received up until 24 April 2018. The following late submissions were received in time to be included in staff analysis and staff recommend that Council accept them:
