# 2.1 Parking Control Bylaw - Coromandel/Colville Schedule A Amendments June 2018

The Community Board advised Mr Edlin, Roading Engineer, of the comments from the public forum regarding forming a driveway at the Coromandel Area School on Tiki Road. Mr Edlin noted he would view the property to determine what the best outcome might be and would respond to the District Manager.

The Community Board requested information from the Police database regarding accidents that Police had attended for 190 Wollams Road, Coromandel.

## 3 Reports

# 3.1 Coromandel-Colville Community Board 2017-2018 Work Programme June 2018 update

**Hauraki Road Bike Park** - Mr Tiplady advised he had attended a meeting with the Spirit of Coromandel Trust to determine the way forward for the project. The Trust had been tasked to provide a more detailed feasibility report.

**Walkways** - The Community Board noted they had not been advised formally that an easement had been granted for the walkway at Whangarahi. Member Autumn advised she would make contact with the owners.

**Hauraki House** - The Community Board noted their support for a request from members of the public regarding disabled access to Hauraki House.



The Community Board queried how artists would book the Barry Brickell stage for performances. Mr Tiplady advised that the process had not yet been completed for booking the stage but he would investigate with the Community Facilities team.

### 3.2 Members' reports

**Chairperson Pritchard** sought support from the Community Board to enter Coromandel into the 'Keep NZ beautiful' campaign in 2019. Chairperson Pritchard noted that the 'Welcome to Coromandel town' sign, needed renewing and advised he had spoken with a local company to come up with a new concept.

Chairperson Pritchard advised that trees near the Hauraki Road toilets need to be removed to allow the CCTV cameras to have visual access.

Chairperson Pritchard commented that with the Hauraki tiles project, there was room for another 300 tiles to be completed and that he was speaking with a trustee of the Barry Brickell foundation to investigate this.

**Member Autumn** noted her concern regarding the lack of disabled access at the front of Hauraki House.

**Councillor Brljevich** advised that he had attended the Mayor's lunch thanking those that had repaired SH25 following the 5 January storm event.
