SUBJECT	Classification of Reserves

1 Purpose of Report

For the Board to recommend the classification for a number of reserves in the Coromandel Colville area, for approval by Council.

2 Background

Under the Reserves Act 1977 (the Act), Councils are required to prepare reserve management plans for all reserves for which they are the administering body, except for local purpose reserves.

Section 41 of the Act sets out the requirements for management plans. Section 41 (3) requires that a management plan shall provide for and ensure the use, enjoyment, maintenance, protection, and preservation, as the case may require, and, to the extent that the administering body's resources permit, the development, as appropriate, of the reserve for the purposes for which it is classified.

The Coromandel-Colville Community Board resolved (CCCB 04/18) to review the Coromandel-Colville Ward Reserve Management Plan in accordance with Section 41 of the Reserves Act 1977.

3 Issue

During the review of the Reserve Management Plans for the Coromandel Colville area, every property was investigated to determine its exact legal status in terms of the Land Transfer Act 1952 and the Reserves Act 1977.

It is now apparent that many of the reserves that appear in the draft management plan that have been vested in Council have not been classified in accordance with the Act. Although all these areas of land are currently included in the management plan, with management policies that are consistent with the purpose and use of the reserve, classification is a necessary process step to ensure that management plan has full force and effect.

Additionally to ensure security of tenure and provide greater clarity for managing the reserves the Board are recommending to Council that the identified reserves be classified in the manner required by the Act.

4 Discussion

Where a reserve has been vested in Council, (where the title is not a Crown derived title) (s16 2A (a)) or the reserve has been created under part 10 of the Resource Management Act 1991 (s16 2A (g)) Council must by resolution classify the reserve according to its principal or primary purpose, typically recreation or local purpose reserve. Notice of the classification must then be given to the Department of Conservation and the classification recorded on the certificate of title.

There are a number of alternative process steps depending on how the reserves have been created or come into Council control although for the purposes of the report they are not relevant.

Where classification is undertaken under section 16 (2A) no public notification is required.

The next steps after resolution to classify are;

1. Gazette
2. Registering on the title

The costs associated with these next two stages will be determined through quotes.

5 Suggested Resolution(s)

That the Coromandel Colville Community Board:

1. Receives the 'Classification of Reserves' report, dated 16 July 2018.
2. Recommends the following land vested in Council be classified in accordance with the Reserves Act 1977, s16 (2) (a)
3. Recommends the following land parcels be classified as "Recreation reserves" in accordance with the Reserves Act 1977, s17
